This well-maintained penthouse apartment is located on the second floor of a modern residential building in a central area of Santanyi. The town centre, with its restaurants, cafés, shops and weekly market, is only a short walk away.

The apartment offers a spacious open-plan living and dining area with an open kitchen. From here, there is direct access to the main balcony, which overlooks the town and offers pleasant views. The fitted kitchen is in excellent condition and is equipped with almost new appliances.

The property comprises two bedrooms. The master bedroom features an en-suite bathroom and access to a second enclosed balcony. This space is fitted with washing machine connections and can also be used as a utility room. Both bedrooms are equipped with high-quality built-in wardrobes.

An additional highlight is the communal rooftop terrace, located one floor above the apartment, offering wide-ranging views over Santanyi.

The property also includes a spacious underground parking space and a private storage room, both conveniently accessible by lift.

The apartment benefits from modern building technology. An energy-efficient heat pump supplies the underfloor heating and the central air conditioning system installed throughout the living room and bedrooms. Numerous floor-to-ceiling double-glazed windows with aluminium frames and aluminium shutters provide excellent natural light and thermal insulation.

This property is suitable both as a permanent residence and as a holiday home, offering comfortable living in a central location with high-quality features and modern amenities.

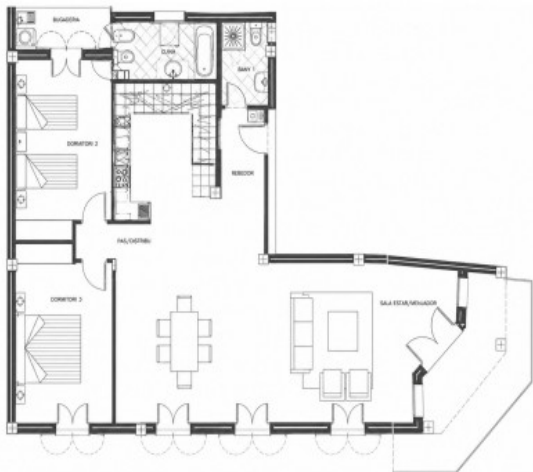
